### *Legal Update*

Michael Lambrix, who used to write our legal column, is sadly not with us anymore, he was executed on October 5, 2017. He is missed and it is our comfort to know he is in a better place now. We keep his family and friends in our thoughts and prayers. Karin Elsea will from now on write the legal columns.

### *Of Information:*

- **Fans** - If you are without a fan or your fan has broken down, and you are without the means to buy one, please let us know and we will try and help you. Please understand that we do need to check whether you have already a working fan in your possession.
- **Medical** - If you want FDRAG to contact Centurion on your behalf it is necessary that you sign a medical release form (DC4-711B Consent and Authorization for Use and Disclosure Inspection and Release of Confidential Information (HIPAA Form) giving medical permission to discuss your care. You can write a DC6-236 Inmate Request to Medical Records asking to be called out to sign a release of information form. You can sign the form to Geesje de Jong, Janneke van Steenberg and Karin Elsea. **Please write to them directly about the medical issues you are seeking help with.**
- **Food/Property Packages** - Packages from Union Supply & Access Securepak for the fall/winter can be ordered from September 27 - October 27.
- **Pictures** - If you have no (recent) pictures of yourself and you have received no visits for at least 90 days to have pictures taken, you can send an inmate request to the admin lieutenant and ask for your picture to be taken, you will be brought to visiting park for this.

### *We contacted DOC for you about...*

(Some issues are ongoing and we are still working on them, please keep us updated)

- **Screens windows - UCI** - Screens were removed for repair, and some of you complained about mosquitos/heat etc. Screens have been repaired and put back.
- **Night Lights/Missing Light Covers - UCI** - The lights on the outer catwalk are being switched on every 30 minutes in the night every time an officer walks through. The constant switching on and off of the twin bulb fluorescent light fixtures, wake the men up all night long. Some of the lights are missing covers. They have been told maintenance department is in the process of securing replacement covers for those, but currently without.. We contacted Secretary Jones and assistant warden on your behalf: - *The light covers were not done on all lights and in many cases were pieces of cardboard and not a real cover. Most of them have fallen down or had to be taken down due to safety issues. We are reviewing some options to help with this but don't have a solution as of yet.*
- **MP3 Players** - issues with MP3 players - *The MP3 player issues are being addressed by the contract company. They are aware there is an issue and are working to correct it.*
- **CFO-Religious-Diet-Menu** - 3 cold meals a day, is it possible to have at least one hot meal a day for inmates on this diet? *The CFO meal is something that is universal statewide. We don't make a determination about what is served. We are unable to serve to anything different than what our menus allows.*
- **Grievances** - complaints that grievances go missing, or not given a reply. *They are picked up by classification staff and placed in a locked box. Each one is logged and tracked very closely. We take the grievance process very serious and know it is the inmates only avenue for complaint and would never restrict that access.*

- **Medical/Centurion** - complaints about medical treatment, behavior of physicians and medical staff towards inmates. Prescription of med's for a limited time and the renewal takes a long time for some that are on continued medication. Centurion is difficult to contact, even when inmates have signed the medical releases forms. - *The medical concerns are always reported when we receive them. Many families reach out to us and we ensure they are provided the information they request. Unfortunately when seeking specialty treatment it can take a long time to be scheduled which is frustrating for families.*
