

To all you brothers at UCI on death row. I beg you to hear my plea. "united we stand, divided we fall! With each month that passes, the powers that be continue to take more from us and try to make our already bad situation intolerable. Stand up, we were not sentenced to hard time, our sentence and punishment is death by execution. We are simply here being "detained" until our sentence and punishment is carried out. There is no justifiable cause for any of us to have to endure any further punishment beyond what the courts have sentenced us to. Our hobby crafts have already been taken and reduced to crappy finger paints and other such junk only a child could use. The rule in which we are to wear class A uniforms between 8:30 am - 5 pm was for the purpose to avoid female employees from seeing us semi-nude, yet now they parade us in the hallways wearing nothing but our boxers to get shaved, which is directly where all the female employees are stationed to work. Our razors have been taken. We lost our chicken, and now we have lost our sausages too! They have been taking the lids from our trays and expecting us to put the trays in the hall for pick-up by sliding the trays sideways through the bars with no lid. Foods & liquids fall to the floor and stick to the cell bars. Make them open the feed slots, that's what they were designed for! Most recently the Warden put out a memo stating our TV's will be turned off for count. Since no clarification was made as to which count, or for how long, our power outlets inside our cells are being turned off every 30 minutes just for a walk through. Power isn't being turned back on for 20-30 minutes, and sometimes longer! Situations like this continue to increase because we are not challenging the changes in numbers. Come together and work as one, help each other and follow the chain of command for the grievances procedures. This is a peaceful protest. Take your fight to them on paper. Do not become the vigilantes in which they are trying to make us out to be. Use FDRAG and other resources available and willing to help. Unite now and fight to keep what we still have, before it's too late and we have nothing left to fight for. Take heed to this message and pass on the word.

You can also send pictures of yourself, your family, that car or dog you so loved, or anything else that you feel would be of interest and would help to show who you are. We will scan and return them to you as quickly as possible.

If your friends or family have pictures that you would like to include, please have them contact FDRAG to make arrangements.

For at the end of the day we're all the same.



### Rick Scott's Prison Budget Ideas

In just over a month, Governor-Elect Rick Scott will take office. At the top of his agenda, a cost-saving overhaul of Florida's prison system. Reporter Troy Kinsey takes us inside a plan critics are already attacking as a threat to public safety

Tallahassee, FL - Here in Florida, life behind bars can be lonely, depressing, and expensive. With more than 100- thousand people locked up, the state's spending almost two-and-a-half billion dollars a year on prisons. If Governor-Elect Rick Scott has his way, they'll have to get by with a billion dollars less.

Scott says, "We'll measure it every day, and we'll come up with things - we'll eliminate ineffective programs, we'll eliminate inefficiencies."

Not surprisingly, the former health care executive wants to privatize inmate clinics. He's also calling for 'market-based salaries' in the prison system, but Matt Puckett with the state's law enforcement union says realistically there's no way to cut a billion dollars without jeopardizing security.

Puckett. Florida PBA, says, "Where are you going to get the other money that it's going to require to take that cut? We think that it's going to be closing facilities and letting inmates go, and that's a prescription for disaster, and we don't agree with that and we will fight it." Attempting to save money through privatization is nothing new, but, this is. The Governor-Elect wants prisoners to grow their own food, potentially cutting the state's grocery bill by tens of millions of dollars. Rob Weissert with Florida Taxwatch calls Scott's plan an innovative way to bring a bloated bureaucracy down to size.

In fact, he says the state can save even more money by letting would-be prisoners join work-release and drug court programs.

Weissert says, "The idea that we need to maintain prisons in order to maintain public safety is a myth; we don't. There are many programs that are actually more effective, that actually enhance public safety."

There's no question the Scott plan would \*unshackle\* big money, but the question is whether it would mean a hidden cost when it comes to your safety.



COLUMBUS, Ohio -The sole U.S. manufacturer of a key lethal injection drug said Friday it is ending production because of death-penalty opposition overseas — a move that could delay executions across the United States.

Over the past several months, a growing shortage of the drug, sodium thiopental, has forced some states to put executions on hold. And the problem is likely to get worse with the announcement from Hospira Inc. of Lake Forest, Ill.

Hospira said it decided in recent months to switch manufacturing from its North Carolina plant to a more modern Hospira factory in Liscate, Italy. But Italian authorities demanded a guarantee the drug would not be used to put inmates to death — an assurance the company said it was not willing to give.

"We cannot take the risk that we will be held liable by the Italian authorities if the product is diverted for use in capital punishment," Hospira spokesman Dan Rosenberg said. "Exposing our employees or facilities to liability is not a risk we are prepared to take."

Italian Health Ministry officials were not immediately available for comment.

All but one of the 35 states that employ lethal injection use sodium thiopental. In nearly every case, they use it as part of a three-drug combination that sedates and paralyzes the inmate and stops the heart.

There are other, similar sedatives on the market, but substituting one drug for another would require new laws or lengthy administrative processes in some states, and could also lead to lawsuits from death row.

Similarly, switching to another manufacturer could invite lawsuits from inmates demanding proof that the drug will not cause pain in violation of their constitutional protection against cruel and unusual punishment. Hospira is the only sodium thiopental-maker approved by the Food and Drug Administration.

Because of what Hospira described as problems with its raw-material suppliers, sodium thiopental is already scarce in the U.S., and any batches Hospira made before it suspended manufacturing more than a year ago are set to expire this year.

In Texas, the nation's busiest death penalty state, the Department of Criminal Justice said Friday it is exploring the use of another anesthetic. The state has four executions scheduled between now and July but has enough sodium thiopental to carry out only two February executions, spokesman Jason Clark said.

Ohio has enough to carry out a Feb. 17 execution but will not comment on its supply after that, or on Hospira's announcement, said Ohio prisons spokeswoman JoEllen Smith.

Hospira has long deplored the drug's use in executions but said it regretted having to stop production, because sodium thiopental has legitimate medical purposes as an anesthetic used in hospitals. Hospira continues to make two other drugs used in executions — pancuronium bromide, which paralyzes, and potassium chloride, which stop the heart.

Without providing details, Rosenberg said the company's state-of-the-art Italian factory was the only plant capable of manufacturing sodium thiopental.

Like most other European countries, however, Italy does not have capital punishment and opposes the death penalty. Italy's Radical Party brought a motion to Parliament, which passed overwhelmingly on Dec. 22, requiring Hospira to ensure that the drug would be used only for medical purposes and would not find its way into prisons.

The current shortage of the drug in the U.S. has delayed or disrupted executions in Arizona, California, Kentucky, Ohio and Oklahoma.

In the fall, states including Arizona, Arkansas, California and Tennessee turned to sodium thiopental made in Britain. But that supply dried up after the British government in November banned its export for use in executions.

Oklahoma went a different route, switching to pentobarbital, an anesthetic commonly used to put cats and dogs to sleep. The state has conducted two executions with that drug.—

## New Florida prisons boss has pedigree

**1:10 A.M.** — TALLAHASSEE - When it comes to Florida's newest prisons boss, it's tempting to think Barney Fife, the overmatched Mayberry deputy in the 1960s television sitcom "The Andy Griffith Show."

Don't be fooled, say colleagues and national experts on prison reform who have worked with him.

As Edwin Buss takes over Florida's Department of Corrections, he's impressed the Sunshine State's powerful prison-guard union with his track record and promises to make cuts in administration, not the front line.

He'll be running a prison system much larger than Indiana's. Florida's prison system has nearly as many employees as the Hoosier State has inmates.

In Indiana, Buss had a \$658 million budget and oversaw 29,000 inmates. Florida's Department of Corrections commands a \$2.4 billion budget and locks up 102,000 prisoners.

But Buss has the right combination of training, temperament and political skills for the job, say those who know him best.

"Congratulations on bringing him to Tallahassee," said Michael Thompson, director of the Council of State Governments Justice Center, who has worked with Buss on prison reform. "Florida won the Buss sweepstakes."

Buss has helped convince law-and-order Indiana legislators to consider dropping rigid sentencing guidelines that flood prisons with low-level drug offenders and others who could be better served in treatment and more cheaply housed in lower-level supervision, Thompson said.

An Army veteran who began in the system as a front-line corrections officer, Buss spent the last 23 years working his way to the top.

In November, Buss told Indiana lawmakers, "politicians have gotten pretty good at playing politics with the criminal justice system."

Buss warned legislators they must rethink their throw-away-the-key mentality. It's possible to spend less and make the public safer, Buss argued. He had the facts and figures to back it up, Thompson said.

"It's a really hard thing to do to convince lawmakers, especially in a place where it's popular to shoot the messenger," he said.

Buss trimmed budgets and cut a staff of 7,500 by 1,000 mostly middle managers. He also consolidated facilities to open up 2,100 new beds and save Indiana taxpayers \$200 million.

"I've been here 20 years and I've seen governors come and go, and I've seen corrections commissioners and secretaries come and go," said Jim Gondles, executive director of the American Correctional Association.

"Ed, in my opinion, is one of the up and coming leaders in American corrections."

Buss also is a believer in rehabilitation and reform, Gondles said.

"Just about everybody we put in prison is going to get out," Gondles said. "We have to lock up the people we're afraid of, not the people we're mad at."

### 'We're impressed'

Kellie Meyer, criminal justice director for the National Alliance on Mental Illness in Indiana, worked with Buss when he was in charge of one of the state's largest prisons in 2004. Buss adopted a NAMI training curriculum that taught staff how to deal with inmates struggling with mental illness.

"Assaults against officers and use of force decreased by 70 percent," Meyer said. "I'm an advocate. I'm the one who speaks up for the people. Commissioner Buss has been innovative enough to work with us. He gets it."

If newly elected Gov. Rick Scott scored a coup by recruiting Buss, he's not eager to tout it. Scott has ordered his appointees not to give interviews.

Scott's criminal justice transition team has proposed many of the same reforms Buss was pushing in Indiana.

A day after Scott's Jan. 4 inauguration, Buss was in Florida asking for a meeting with the Florida Police Benevolent Association. It was an unusual request.

Scott has vowed to trim the state work force by 5 percent and slash the Department of Correction's budget by \$1 billion, putting him in opposition to the powerful police union.

When the PBA endorsed Scott's opponent, executive director David Murrell warned Scott's budget cuts would put serial killers back on the streets. But the PBA is backing off after two of its top officials met with Buss.

"Originally, everybody said, 'Hey, wait a minute, this guy is coming from a much smaller state,'" said PBA spokesman Matt Puckett, who attended the meeting. "I think it's safe to say we were very much impressed."

Buss pledged staff cuts will come from middle management and front-line workers, prison guards and probation and parole officers, will be preserved, Puckett said.

### **Revolving door**

The Florida Department of Corrections has had two secretaries in the past four years. Jim McDonough, a former Army colonel and drug czar who worked in the Clinton White House, had impressive credentials and was brought in to right a ship plagued by scandal.

McDonough stressed rehabilitation and many of the same money-saving reforms Buss pushed in Indiana, but with little success in the Legislature.

He clashed with the corrections culture that bristled at his rigid leadership style, Puckett said.

"He wanted everybody to be Army Rangers, even though they weren't hired to be Army Rangers," Puckett said. "He thought he was going to come in and dictate changes without bringing everybody to the table and people would just obey."

Buss will replace Secretary Walt McNeill who had impressive credentials as a former Tallahassee police chief, but little corrections experience and not enough time on the job, Puckett said.

"Part of the problem is that nobody's been there for more than two years," Puckett said. "We give football coaches more time than that before we decide how they're doing."

In response to contact from both convicts and Correctional Officers, LOLITS contacted Regional Director Timothy Cannon on behalf of both FDRAG and LOLITS. Below is a summary of the e-mail exchange. We await word from those of you who live and work inside to let us know if Mr. Cannon missed anything while on the tour.

\*\*\*\*\*

LOLITS - As you know I usually work with the open population. However from time to time I do get messages from inmates and families on Death Row. I used to work closely with a group called FDRAG that is mostly for Death Row at UCI and FSP. I have received a few calls from families of guys at UCI and also have spoken recently with FDRAG members. I want to share with you our combined issues.

**DOC - Thank you for the opportunity to review and respond to the issues that you have presented. I will attempt to address each issue individually. I personally visited Monday, January 10, 2011, and will continue to visit unannounced.**

LOLITS - The power is being shut off for count time without warning (on some wings) and the fuses on the TV's are blowing out when the power is turned back on.

**DOC - The power is not being shut off at count time; however the inmates are required to turn their televisions off during count which is required by count procedures.**

LOLITS - They will be advised the power is not being turned off, it is their duty to turn off the TV's during count

LOLITS - There is a new rule in place mandating that only one thing can be out of a locker at any given time.

**DOC - We are not aware of any rule that restricts the inmates to having only one item out of their locker at a time. Lt. Adkins was interviewed regarding this allegation and he advised that he is not enforcing such a rule and that he is not aware of any of his staff doing so either. If you have specific incidents or names of staff that are enforcing such a rule, we would be glad to revisit this allegation again.**

LOLITS - I will tell FDRAG to let the guys know that the one thing at a time is no longer in effect and if they are told this to get the name of the officer and report back to them or me.

LOLITS - The men are told they must be fully dressed "when it gets cold".

**DOC - Lt. Adkins was also interviewed regarding the allegation that the inmates are required to be fully dressed "when it gets cold". He advised us that the inmates are required to be dressed during business hours, Monday through Friday, regardless of the temperature. This is done in an attempt to have the inmates presentable during higher traffic times on the wings.**

LOLITS - We will let the guys know they are required to be dressed during business hours Monday through Friday so they are presentable during the higher traffic travel in the wings.

LOLITS - The clippers are not being properly cleaned or sanitized between uses.

**DOC - Clippers are being used in Death Row now as a means to save money and increase safety and security. The clippers are being sanitized and maintained in accordance with established procedures.**

LOLITS - The food trays that are passed to the men through the bean flaps, must be passed back through the bars as the officers will not open the flaps to receive the trays. Since there are no lids on the trays, food and liquids are spilling onto the floor. The floors are not properly cleaned.

**DOC - Warden Reddish advises that he has personally observed the feeding process on several occasions and the inmates are delivered their trays through the cuff ports. When the inmate runners return to pick up the empty trays, the cuff ports are not typically opened because the death row inmates pass the empty tray back through the cell bars vertically. In those cases where something may get spilled, the inmate runners are available to clean it up.**

LOLITS - Hopefully in the future the runners will be told to clean up the spills from the trays as it happens

LOLITS -- The showers are filthy and many of them have mold.

**I personally inspected several showers and wings during my visit on Monday. The showers were clean and the wings were found clean and quiet as well.**

LOLITS -- There is now a procedure in place where the security staff has to line up and stand at attention at one or the other of the gates at certain times, for unclear reasons.

**For a short time, Administrative Security Staff were required to be in formation for an inspection at the beginning of their shift. This practice is not being used at this time.**

LOLITS - The floors are not properly cleaned, other than the "tour wing" that we are told is the only wing that Warden Reddish visits on death row.

**Mr. Reddish tours the institution on a regular basis and spends time interacting with staff in their respective areas. He does not conduct rounds in P dorm on a "tour wing". He randomly tours different wings to ensure that cleanliness and sanitation is being maintained and to afford the inmates an opportunity to speak with him about housing conditions, visitation regulations, etc.**

LOLITS - The guys will be asked to let us know about the opportunity of talking to Warden Reddish when he tours their wings

LOLITS - The staff are concerned about various issues, but are afraid to say anything for fear of being written up and losing their jobs.

**Staff are always encouraged to address their issues at the local level through their chain of command. Some staff have done this and the Administration has listened and afforded them the opportunity to be heard. If they are not satisfied with the response they receive, they can speak with the next person in their chain of command. We are always concerned with staff morale..**



    veggie chicken salad             **Chicken flavored TVP**

Can you please provide us with the ingredients of the texture vegetable protein (TVP) which appears to be included in a number of the meals? **TVP is Textured Vegetable Protein and is soy bean based.**

Also, can you tell us how the DOC monitors the actual food preparation and service, who does the monitoring, and how often? **Each meal preparation is over seen by staff assigned to the institution, and service is monitored and recorded on a per meal basis at the facility. Central Office staff assigned to each region monitor each kitchen on no less than a quarterly basis and more often if issues are present. Department of Health inspects each kitchen on a quarterly basis.** **Albert Thigpen**

Thank you for this information, but we are coming back to you because we need even more. What are the actual ingredients in this TVP? Who provides it, who makes it, and how can we get that information? We want to know exactly what it is made of and how to make it ourselves. ## **Textured vegetable protein**

**Textured** or **texturized vegetable protein (TVP)**, also known as **textured soy protein (TSP)**, **soy meat**, or **soya meat** is a meat analogue or nutritious meat extender made from defatted soy flour, a by-product of extracting soybean oil. It is quick to cook, with a protein content equal to that of the meat, and contains no fat.

### **Manufacturing process**

TVP is made from a mixture of proteins extracted primarily from soybeans, but also cotton seeds, wheat and oats. It is extruded into various shapes (chunks, flakes, nuggets, grains, and strips) and sizes, exiting the nozzle while still hot and expanding as it does so. The defatted thermoplastic proteins are heated to 150-200°C, which denatures them into a fibrous, insoluble, porous network that can soak up as much as three times its weight in liquids. As the pressurized molten protein mixture exits the extruder, the sudden drop in pressure causes rapid expansion into a puffy solid that is then dried. As much as 50% protein when dry, TVP can be rehydrated at a 2:1 ratio, which drops the percentage of protein to an approximation of ground meat at 16%. High quality TVP can be mixed with ground meat to a ratio of up to 1:3 (rehydrated TVP to meat) without reducing the quality of the final product, sometimes improving it if the meat used is poor. TVP is primarily used as a meat substitute due to its' very low cost at less than a third the price of ground beef, and when cooked together will help retain more weight from the meat by absorbing juices normally lost.

**Properties;** TVP can be made from soy flour or concentrate, containing 50% and 70% soy protein respectively, and is relatively flavorless. Both require rehydration before use, sometimes with flavoring added in the same step. TVP is extruded, causing a change in the structure of the soy protein which results in a fibrous spongy matrix that is similar in texture to meat. In its dehydrated form TVP has a shelf life of longer than a year, but will spoil within several days after being hydrated. In its flaked form TVP can be used similar to ground meat.

**Uses:** Textured vegetable protein is a versatile substance, different forms allowing it to take on the texture of whatever ground meat it is substituting. Using textured vegetable protein, one can make vegetarian or vegan versions of traditionally meat dishes such as chili, spaghetti bolognese, sloppy joes, tacos, burgers, or burritos. Soy products also are used as a low cost substitute in meat and poultry products. Food service, retail and institutional (primarily school lunch and correctional) facilities regularly use such "extended" products. Extension may result in diminished flavor, but fat and cholesterol are reduced. Vitamin and mineral fortification can be used to make soy products nutritionally equivalent to animal protein; the protein quality is already roughly equivalent.

Textured vegetable protein can be found in natural food stores and larger supermarkets, usually in the bulk section. TVP is also very lightweight, and is often used in backpacking recipes. TVP is often used in prisons and schools for several reasons: its low relative cost, high protein and low fat contents make it ideal, as does its relatively long shelf life, which allows institutions to buy in bulk.

If additional information is required from anyone, FDRAG will list the reference numbers in a subsequent newsletter with instructions as to what else you might need to do.

We will not provide actual copies of the letters received to the DOC. Also, we will not quote anything that is written. Instead we will summarize the issues that are raised.

Both of these actions are intended to protect your anonymity.



If you are not 100% sure about the accuracy or validity of something that you are sharing with us, or if it is only a rumor, please make that clear when you write.

Whatever you do, we encourage you to speak out about any issues or concerns that you have.
